

Message From 2016 National President Calvin Shelton

Are We Asking?



This has been a great year and I have enjoyed every moment serving as your National President. My wife Patsy and I have been allowed to share in numerous club anniversaries, celebrations, and community events. We've had fun visiting clubs and

meeting our Ruritan family, but we have also struggled with trying to accomplish some things that we feel are important to our organization.

I am thankful for the clubs that have been chartered. But there should have been a lot more.

I am thankful for the members that have been brought into our organization. But there should have been a lot more.

I have tried to encourage and emphasize that we need more involvement with our clubs. We need more people willing to serve our organization. We need more people willing to step up to the plate and do what needs to be done, whether its politically correct, or not!

As I think about our past leaders, I can't help but think of the years of experience and the knowledge we have in our organization. If we could bottle all of this wisdom and talent, there is nothing that we could not accomplish.

Most of these leaders know what it takes. But are we, and I'm including myself, passing this knowledge to the people who are building this organization by bringing in new members and growing new clubs? For some reason, we have lost our desire to mentor our club leaders.

Membership was at its highest in 1978 with 38,790 members. As of November 1, we had 26,237 members. In 1991, we had 1400 clubs. Today we have 1019.

What's happened?

Some will tell you that we are just getting older. They say, "Many have died." People will tell you that young families are just too busy these days to commit to Ruritan. I say "Nonsense!" I know of no one who doesn't make time for doing the things they

enjoying doing.

I think that we (yes, myself included) - the Baby Boomers - have failed. Baby Boomers were those people born between 1946 to 1964. We would have been between 14 to 32 years of age in 1978.

We were more privileged than our parents had been. Yes, they wanted to give us what they never had. I'm not sure they did us any favors.

We became a spoiled, self-centered society. We quit thinking about others and we quit contributing to our fellow man.

We quit working for our organization. Many were content to just come to the club meetings, eat, burp, and go home.

We weren't committed to growth, and it began to show in our numbers. We did the same thing, the same way, and we got the same results.

Woody Allen said, "90 per cent of success is showing up."

In the creative sense, showing up doesn't just mean arriving at a place — it means being prepared to put in the work, regardless of outside factors or obstacles, including your own naysaying mind. Painter Chuck Close spoke about this, when he noted that "inspiration is for amateurs...the rest of us just show up and get to work."

How many of you have ever heard, "But we've always done it that way?"

If you're a committed, dedicated Ruritan, then your job never ends. We all are expected to bring in new members, encourage present members, and help organize new clubs.

If we don't step up to the plate, then we can only blame ourselves for Ruritan's decline.

Another point that I've preached all year is that "we have to find our replacement."

At your next club meeting, look around and count all of the grey heads. We're not going to be here forever. Like it or not, we will die at some point. Why not have someone that you mentor and train, to take your place?

Myles Munroe said "Success without a successor is failure!"

We may have the biggest, greatest club in the organization - but if we don't have successors, then in

Board Approves Changes to Blue Ribbon Award

At the August meeting the Ruritan National Board of Directors voted to redefine the attendance requirements for the Blue Ribbon Award earned by clubs. If the 90% attendance requirement and/or membership increase are too hard to achieve, a club can compensate for lower attendance by having up to three GOLD Community Service Awards. See page 9 for the new form and the revised wording for item "a." The rationale for the motion was to give more value to clubs excelling in community service.

In addition to this change the board revised the prizes for achieving Blue Ribbon status. Clubs applying for the award can now choose the traditional felt banner **or** a certificate and \$150 credit toward either the national convention registration or Ruritan supplies. The rationale for this change was that many clubs do not have a permanent building and cannot display a wall of Blue Ribbon banners. This change also allows clubs that aren't as interested in the traditional felt banner to strive for a more substantial prize.

A new Blue Ribbon form is featured in this issue of the RURITAN magazine on pages 9-10. These changes will apply to the judging of 2016. Applications are due by Feb. 10 each year.

Message From 2016 Foundation President Fred Payne

Scholarships Achieve Ruritan Foundation and Club Goals



In May and June, Ruritan Clubs across America awarded over 400 Ruritan National Foundation (RNF) scholarships to local students to attend their educational institution choice. Scholarship recipients visited club meetings and told stories of how their award enabled them to continue their education and change

their lives. Photos and stories of student recipients and club members were featured in local papers, our Ruritan magazine, and on social media.

Scholarship awards fulfill the purpose of Ruritan Foundation Bylaws. "The Foundation gives grants to individuals for post-secondary education.... Income from growth in investments, interest and dividends will be used to fund the educational programs of the Foundation."

Last year, the Foundation awarded, and local clubs presented, over 400 scholarships, primarily Build Your Dollar (BYD or BY\$) awards. BY\$ scholarships are enabled by unrestricted or general funds accumulated since 1968 through special gifts from districts, clubs, and individual permanent funds. contributions to Birthday, Permanent, Tom Downing, club, and district funds, as well as Special & Friend Educational Funds, help build the Ruritan Foundation corpus.

Tom Downing is the largest unrestricted fund in the RNF endowment, with a 2016 balance over \$740,000 which generates unrestricted earnings that are used for BY\$ scholarships and other RNFI costs. Tom Downing was an outstanding leader, a co-founder of Ruritan, and first National Secretary of Ruritan. Thus Tom Downing Fellow awards honor outstanding members and citizens, and over 1,450 of their names are listed on the RNF online website. In 2015 and 2014 RNF unrestricted funds grew by a total of \$48,500 as clubs recognized 47 and 50 Tom Downing honorees and the RNF received \$500 each. Many districts pay \$250 of the \$500 cost to encourage clubs to honor local leaders with Tom Downing awards for exemplary service.

<u>District Funds</u> collectively represent over \$900,000 of unrestricted corpus that generates earnings that are used for BY\$ scholarships and other general

RNFI costs. In 2016, two district unrestricted educational funds are over \$100,000. Potomac District has \$172,000 and Ohio District has \$109,000. Piedmont District is third largest at \$64,000. All other district educational funds have a combined value of about \$600.000.

Birthday Fund gifts, either \$10 or \$2 per member, are used by many Ruritan Clubs to recognize members. Birthday gifts are designated for the club's permanent fund RNF corpus or held for OWC use as relief funds. Net annual unrestricted RNF earnings pay for BY\$ scholarships.

Permanent Funds honor a named club, individual or family and about 1,800 are recorded. Currently, about 1,000 funds are above the \$1,000 level for an established Permanent fund, 340 funds exceeded the 21st Century level of \$2,100, and 120 funds achieved the Cornerstone level at \$5,000. Many clubs and families are completing their own named permanent funds by moving up the "steps" from \$1,000 toward a \$10,000 endowment level.

Endowed restricted funds, for named club or individual scholarships, are growing. In 2016 fiscal year, at the fiscal year end, four Golden '68 Funds had \$50,000 or more, fifteen Special Funds had \$20,000, and 28 Friends Funds had \$10,000 or more. Earnings from the corpus of these endowed funds allow clubs to award local, donor designated scholarships.

All Ruritan scholarships change local lives and deserve recognition! The 2016 <u>Ruritan Annual Report</u> to be released at the January 2017 National Convention will celebrate gifts supporting Ruritan scholarships through RNF funds. The report recognizes Ruritan Clubs and individuals that gave to Tom Downing, District, Permanent, and Birthday Funds, as well as Special & Friend Scholarship Funds to promote educational scholarships and serve our communities.

To build your named fund, please contact a RNF Trustee or District RNF Promotion Chair. RNF Trustees responsibly manage and maintain the corpus in perpetuity to achieve donor goals. Prudent corpus investments produce earnings that support scholarship grants to local students. Your continuing investments grow corpus, and increase Foundation scholarship awards.

"I am grateful that I had the opportunity to become a member of and participate in my high school's Ruri-Teen club over 10 years ago, and I have continued to carry out Ruritan National's mission of making

communities a better place in which to live through fellowship, goodwill, and community service," Denee' said in a recent interview.





A Perpetual Life Plan

Protecting and preserving Ruritan as a legacy for future generations.

"Ruritan Forever" is a plan for the payment of <u>national</u> dues by members who wish to make a long term investment in Ruritan. The "Ruritan Forever" plan allows a member in good standing to pay \$600 and become a life-time participant of the National Organization. Ruritan National will invest these prepayments in a special managed fund, transferring the dues quarterly to the business office of Ruritan National. Even after the life participant dies, dues will be transferred quarterly to Ruritan National, thus offering a perpetual memorial to the organization on behalf of the deceased Ruritan.

A "Ruritan Forever" endowment may be purchased by a member in good standing or may be purchased for a member in good standing. A Ruritan Forever endowment may be purchased to honor a non-member provided they are brought into a club as an Associate Member at the same time. In this case the Associate Member's dues would be covered by the \$600 endowment.

The lifetime endowment may also be purchased in

memory of an already deceased Ruritan, ensuring an ongoing contribution to the operation of Ruritan in his or her name. Dues for a living participant must be current through the previous quarter to participate. Ruritan National will administer these prepaid dues in a separate fund with the original amount remaining in perpetuity. Interest on the fund will provide the money paid to Ruritan National for dues.

Upon payment of the fee, the Ruritan will receive a certificate, a lapel pin, and a permanent life participant card. For endowments purchased for a deceased member a special plaque will be provided for the club to present to the deceased member's family. **National** dues increases will have no effect on participants enrolled in the plan, although the purchase price of \$600 for new enrollees may be adjusted over the years as necessary. There will be no special assessments or charges made to Ruritan Forever participants.
